ORDER

WHEREAS, Uluberia College, P.O. – Uluberia, Dist. – Howrah, West Bengal-711315 (APE00688) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2008-2009 vide ERC order dated 04.08.2008, followed by revised recognition order issued on 25.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. AND WHEREAS, the ERC in its 272nd meeting held on 30th – 31st May & 1st June, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 60685 dated 14.06.2019 from the academic session 2020-2021 to the institution.

3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 14.06.2019. The Appellate Authority vide order No.89-366/E-135666/2019 Appeal/33rd Mtg.-2019/21st November, 2019/85842 dated 05/12/2019 remanded to the ERC with a direction to consider the two FDRs submitted by the appellant and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC the originals of the FDRs, if necessary, with 15 days of receipt of orders on the appeal.

4. AND WHEREAS, the ERC in its 279th meeting held on 14th – 16th February, 2020 considered the matter and as decided, Show Cause Notice was issued on 28.02.2020 to the institution on the following grounds:

(i) Original FDRs of Rs.5 lakh and Rs.7 lakh to be submitted.

5. AND WHEREAS, the institution submitted reply vide letter dated 27.02.2020 received in this office on 28.02.2020. The ERC in its 280th meeting held on 29th February & 1st March, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and decided as under:-

“Restoration of recognition order of B.Ed. course to be issued”.




